Commissioner Skrinde motioned to accept the January minutes; Commissioner Horton seconded; motion carried.

Commissioner Horton motioned to accept financial report & bank statements, County Report & Treasures report, Commissioner Skrinde seconded; motion carried.

The Chief has reached out to insurance and will reach out to the district's attorney. Commissioner Horton motioned to move forward with the loan of the Engine as long as the district's attorney is involved in writing the agreement, Commissioner Skrinde seconded; motion carried.

Old Business-

Policy- Commissioner Horton motioned to replace Policy 17. Cash receipting with new policy 17. Administration Procedures as presented, Commissioner Skrinde seconded; motion carried. Commissioner Horton motioned to adopt policy 31. Abuse Mandatory Reporting as presented with one minor change, Commissioner Skrinde seconded; motion carried.

New Business-

BP compensation - Commissioner Stratton stated that there may have been some confusion, he would like to make it clear he did not negotiate or contact BP regarding the district expectation of funds. He was contacted and told that the district should expect to receive funds from BP. Chief stated that the district did receive an additional \$15,000 from BP and is considering purchase of a Gator type vehicle to pull the district marine rescue boat/hover craft and for rescues on the dikes.
